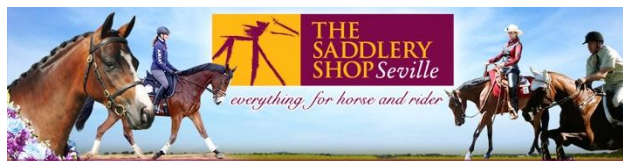

**All tests will be ridden on “all weather arenas”**

**Entry Fee \$26.00 for 1 test, or \$51.00 for both tests, \$21 for Grade 5A (includes \$1 zone levy)**

**Open riders need to provide proof of insurance or pay \$10 per day attendance. See page 2**

**Competitors must supply their own back, bridle or saddle blanket numbers (see item 12. below)**

**Entry is conditional upon acceptance of these conditions. Please read carefully to avoid disappointment.**

1. Entry Fee is \$26 for one test OR \$51 for both tests, \$21 for Grade 5A
2. **PCAV membership cards** must be inspected at the secretary's office before riding. Riders must have both new seasons card 2015/2016 and old 2014/2015 card. For insurance reasons, there will be no negotiation on this issue. **No New Card, No Ride.**
3. There shall be no refunds after 15th of August unless [kslade@eventsecretary.com.au](mailto:kslade@eventsecretary.com.au) notified prior to ride time and a valid veterinary or doctor's medical certificate is provided within 7 days of notification. All refunds will incur a \$10 administration fee
4. Entering this competition constitutes acknowledgement that PCAV rules apply and your acceptance of these rules.
5. The organising committee reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating a reason.
6. All riders must wear complying helmets ie; AS/NZS3838, ASTM F1163, PAS015. Spot checks to ensure compliance will occur.
7. Gear check: required for all riders before the first test at least 15 minutes prior to riding time.
8. Medical armbands **must** be worn by all competitors.
9. Queries, protests, horse abuse as per the PCAV *Handbook of By-Laws*.
10. Dogs are prohibited without exception.
11. No stallions, colts or rigs.
12. Competitor numbers - the organising committee will allocate and advise numbers. Competitors must supply their own numbers and holders. Bridle or saddlecloth numbers must be placed on both sides of the horse
13. PCAV Alcohol Policy applies.
14. Neither the organising committee of this competition nor the PCAV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other person or property.
15. Strictly no lunging allowed at this event, due to lack of space.
16. For safety of horses and riders, please note all horses must be securely tied up within the grounds. Any horses tied up outside the grounds may be eliminated from the event.

**If Applicable: Open sections add \$10 Day Attendance Fee** Participants do not need to pay \$10/day if they are a current member of, and can provide proof of membership of:

- Pony Club Association of Victoria;
- Equestrian Australia\* (EA);
- HRCAV
- an InterState Pony Club;
- Arab Horse Society of Australia (AHSA);
- Australian Endurance Riders Association (AERA); or
- can provide proof that they are covered by Public Liability Insurance Policy with a minimum of \$10,000.000.00
